## Returns

No returns will be accepted without first calling Coastal Moto to obtain an RA Number. Write this RA Number clearly on the box. **No returns will be accepted once the items have been mounted on the bike or if a tire has been mounted.** A restocking fee of up to 25% may apply. Return requests will only be considered if request is made within 30 days from the date of invoice. NOTE – All parts returned must be properly packaged. Customer is solely responsible for parts damaged in shipping due to inadequate packaging.

## For Dealers Only - Minimum Advertised Price Policy

In an effort to protect our brand and dealer network, Coastal Moto reserves the right to unilaterally terminate dealer status with any dealer that advertises Coastal Moto products at a price less than the manufacturer's suggested retail price. We will provide updates in the event our suggested retail price changes. Please contact us directly if further pricing clarification is necessary.

## Warranty Coverage

Contact Coastal Moto at 888-899-6686 to obtain a return authorization number. Coastal Moto products have a one year limited warranty from the Coastal Moto date of invoice against all material or workmanship defects. If returned within one year from the date of purchase, we will replace it, or at our discretion, repair it at no cost to you with the exception of any labor costs incurred for which Coastal Moto is not responsible.

## Warranty Exclusions

Warranty does not cover damage caused by accident, misuse or failure to follow installation and operation instructions, misapplication, alteration or attempted unauthorized repair service by anyone other than Coastal Moto. Labor and or paint costs incurred in connection with any warranty claim are NOT covered.

## Limitations of Warranty

Repair or replacement of Coastal Moto product by us is your sole and exclusive remedy. Implied warranties, including those of fitness for a particular purpose and merchantability, are limited to the (1) year term of this express warranty. We will not be responsible for incidental or consequential damages. There are no express warranties which extend beyond those set forth in this document.

## 2 Year limited Chrome Wheel Warranty

The chrome plating on Coastal Moto wheels is among the highest levels on the market today. Each Coastal Moto wheel bears a 2 year limited chrome warranty against defects. The condition and appearance of chrome plating is dependent on user care and maintenance. Products should be maintained properly by cleaning with mild soap and water and waxing with a high quality carnauba wax. **Do not use abrasive cleaners or waxes.** Small flaws or marks do not constitute a flawed product. Corrosion defects due to salt spray in beach or snow areas, corrosive chemicals, improper care or cleaning are NOT COVERED by warranty. Coastal Moto reserves the right to determine if the product has been maintained properly and has not been abused or neglected. Parts must be returned to Coastal Moto for repair, replacement or credit. No credit will be issued under any circumstance for labor or any other cost incurred beyond the original cost of the part.

## Exchanges or Missing Items

Incorrect, damaged, or missing items MUST BE REPORTED WITHIN 72 HOURS of the time product is received. YOU MOUNT IT YOU BOUGHT IT. No exchanges will be accepted after 30 days from invoice date.
